It acts as a catalyst for sustainable growth of business between India and the US. IACC promotes bilateral trade, investment and technology transfer, facilitates business collaborations, joint ventures, marketing tie-ups and strategic alliances through a set of proactive business-oriented initiatives. The chamber had organized several business programs having high social impact in the Education, Aviation & Aerospace, Energy, Infrastructure and other Industry sector.

Telangana State Council of Higher Education (TSCHE)

Telangana State Council of Higher Education was constituted as State Council on August 5' 2014. Telangana State Council of Higher Education is a Statutory Body of Government of Telangana which is responsible for coordination and planning of Higher Education.

Objective

The objective of this Memorandum of Understanding (MOU) is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the intellectual life and educational development in Telangana and to contribute to increased international cooperation in the field of Higher Education. IACC and Telangana State Council of Higher Education have agreed that in support of their mutual interests in the field of education and research the MOU is arrived at.

The broad objectives of the MoU are:

- Preparation of consolidated programmes in the sphere of Higher Education in the State and to evolve perspective plans for development of Higher Education in the State
- Promote cooperation and coordination of the Educational Institutions among themselves and explore the scope for interaction with industry and other related

establishments and to encourage and promote innovations in curriculum development, restructuring of Courses and updating of syllabi in the University and the Colleges

The two Institutions herewith agree to:

- a) Conduct Seminars, Conferences, Workshops etc to disseminate information about Higher Education opportunities in India and US.
- b) Provide guidance regarding career opportunities and options for visiting students from India and US.
- c) Work with Universities and other higher educational institutions in India and US for exchange of knowledge and skills.
- d) Cooperate in exchanging of information relating to activities in teaching and research in fields of mutual interests.
- e) Promote appropriate joint research projects with particular emphasis on internationally funded projects.
- f) Assist student and faculty visits to promote short term industry programs/ internships.
- g) Foster innovation, incubation and encourage entrepreneurship to improve the overall skills of students in India and US.

The above MoU shall be valid for a period of 2 years form the date of entering the MoU.
