The above registration fee includes:

- d. **Meetings with Government officials from India and USA:** Depending on availability and scheduling, registered participants may have the chance to meet and interact with Government officials from India and USA. GENERAL PROCEDURES:

1. All other expenses (international airfare, visa fees, travel insurance, domestic/local travel, accommodation, food, etc.) to be paid by the delegate as per the actuals.
2. In case delegation is cancelled by IACC then Registration Fee will be refunded after deduction of actual cost, if any.
3. In case of cancellation by the delegate, the refund would be:
 - a) 75% prior to 45 days of the delegation date;
 - b) 25% prior to 30 days of the delegation date;
 - c) No refund if less than 30 days of the delegation date.
4. In case visa is non-granted, 25% will be retained from the registration fees and rest will be refunded.
5. Total cost of the travel expenditure per delegate will be informed once we know the actual number of registered participants.
6. IACC reserves the right to cancel and or change the delegation process at any stage without assigning any reason.
7. IACC reserves the right to accept or reject any or all the applications received at its discretion, without assigning any reason whatsoever.
